8. That the school will ensure the compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.

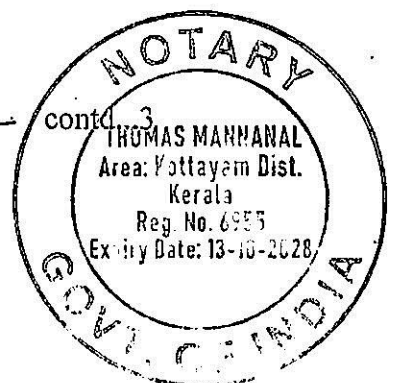

17. That the school will not sponsor students from other Board.

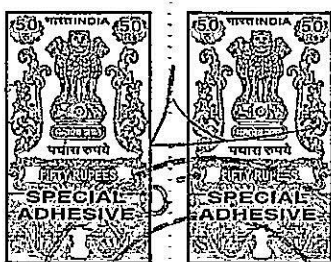

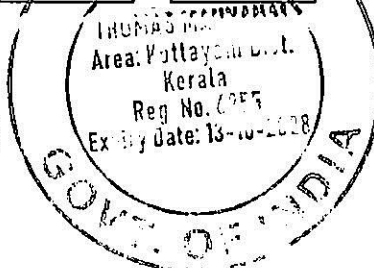
